Public Participation

President Bransford called for public participation and asked if anyone would like to address the Board and as no one from the public wished to address the Board, the meeting continued.

ADMINISTRATION

Water Operations

Water Operations Superintendent Shipley reported that Term 91 is currently lifted but close to being imposed. The system would remain charged for deliveries to the refuge even if Term 91 is imposed because they do not fall under the same requirements. He reported that approximately 21,000 acres have applied for water under the District's winter water permit. To put that number into perspective, there are approximately 24,000 acres of permanent

crops in the District. He added that the District is still unsure of what its SRS Contract water supply will be at this point, and the District is preparing for several different scenarios. Once the water supply amount is known, the District will reach out to water users and host a landowner meeting to convey what the District's plan will be. The District will also be working closely with Water Operators to develop water operator area budgets to utilize and deliver water in the most effective and efficient way possible.

General Manager Bettner provided a report on supply and negotiation discussions. He reported that we are currently looking at the driest of dry conditions on the Sacramento River. Concerns regarding Salmon survival and cold water storage continue to be a topic of discussion and modeling efforts are occurring to support those conversations.

General Manager Bettner added that he has participated in several meetings including those with Jered Blumenfeld of the Cal. Environmental Protection Agency, Chuck Bonham with California Department of Fish and Wildlife, Bureau of Reclamation Regional Director Ernest Conant, Director of Fish and Wildlife Services Paul Souza, and National Oceanic and Atmospheric Administration Assistant Regional Administrator Cathy Marcinkevage.

He also added that the State Water Resources Control Board (SWRCB) must approve the Temperature Management Plan. There are different opinions of how long the process will take but people understand that this is critical and needs to be expeditiously addressed. He also reported that they are hoping to come to an agreement on water supply/operations by April 1.

2020-2021 Audit Presentation by Richardson & Company and Approval of Audit Report Finance Director Louis Jarvis introduced Ingrid Sheipline of Richardson & Company, who delivered the GCID audit presentation for fiscal year 2020-2021. Ms. Sheipline reviewed several portions of the audit report and noted one adjustment that will need to be made to the review process of billing adjustments. She reported that GCID staff did an excellent job with the financials for the District. Finance Director Jarvis added that GCID has signed a new 5-year term with Richardson & Company and said the District has appreciated all of Ms. Sheipline's work with regard to the District audit process.

The Board thanked Ms. Sheipline for her services and for taking the time to provide a thorough report to the Board.

Director Dennis moved to approve the 2020-2021 audit report. Director Vann seconded the motion and it was unanimously approved by the following vote:

Report from GCID Communications Consultant CV Strategies

CV Strategies Director of Account Management Janet Zimmerman provided a report on activities over the past several months and progress being made on the development of a new GCID website. She reviewed the newly formatted District newsletter the GCID Currents, and staff bulletin *The Channel*. She showed samples and explained the process of developing the new logo, stationary, agendas, board packet covers and new GCID website.

The District is excited about the re-branding and new direction of GCID communications. The Board thanked Ms. Zimmerman for her and CV Strategies' hard work thus far and thanked her for taking the time to provide an update to the Board.

Maintenance

Maintenance Superintendent Richardson reported that the Maintenance Department has completed the 25-1 long-crested weir, completed the 47-1 culvert failure repair, replaced the SC-1A private drain, begun work on the 22-1 private drain siphon, repaired a private drain siphon at Lynn weir, and continued spraying and mowing in various areas. He also reported that they are working to coordinate on the Viera/Sites drain issue, coordinating with Glenn County for upcoming culvert replacements, and working on a dredge agreement with Tehama-Colusa Canal Authority. Upcoming work will include the repair of small holes in the canal at Road V and interviews for Maintenance, Abatement and Fabrication positions.

Engineering

District Engineer Dickens reported that the Engineering Department is continuing to assist with the coordination of failed culvert replacements. They are also reinitiating the design coordination for Abel Check and Lurline Check. He reported that the Engineering Department has surveyed levels of approximately 18 wells withing the District.

Water Resources

Water Resources Manager Dawley reported that the Gradient Facility team is working to examine possible phasing of project elements to optimize construction opportunities and move up the implementation schedule. She also reported that funding continues to be the next challenge as agencies implement the Sustainable Groundwater Management Act.

Finance Director Jarvis provided a report on the Treasurer's Report, Financial Report and Damage Claims Report for the month of February.

RESOLUTION NO. 2022-10

A RESOLUTION OF THE BOARD OF DIRECTORS OF GLENN-COLUSA IRRIGATION DISTRICT RE-AUTHORIZING REMOTE TELECONFERENCE MEETINGS IN ACCORDANCE WITH GOVERNMENT CODE SECTION 54953(e)

WHEREAS, Glenn-Colusa Irrigation District (District) recognizes the importance of transparency and clear communication in government, and is committed to full compliance with the letter and spirit of the Ralph M. Brown Act (Gov. Code, §§ 54950 – 54963) (hereinafter "Brown Act"); and

WHEREAS, all meetings of the District's Board of Directors are open and public, as required by the Brown Act, so that any member of the public may attend and participate; and

WHEREAS, the Brown Act, (Gov. Code, § 54953, subd. (e)), allows members of a legislative body to participate in meetings remotely, without compliance with the requirements of Government Code section 54953, subdivision (b)(3), if a state of emergency is proclaimed pursuant to Government Code section 8625 and state or local officials have imposed or recommended measures to promote social distancing, or meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, the District's Board of Directors previously adopted Resolution 2022-02 on January 25, 2022 finding that the requisite conditions exist for the District to conduct remote teleconference meetings pursuant to Government Code section 54953(e); and

WHEREAS, pursuant to Government Code section 54953(e)(3), the District is required to reconsider the circumstances of the state of emergency every thirty days.

NOW, THEREFORE, BE IT RESOLVED by the Glenn-Colusa Irrigation District Board of Directors as follows:

- 1. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.
- 2. The Board of Directors has reconsidered the circumstances of the state of emergency.
- 3. The Board of Directors does hereby find that the State of Emergency proclaimed by Governor Gavin Newsom pursuant to Government Code section 8625 on March 4, 2020 remains in effect and emergency conditions continue to persist in the District.
- 4. The Board of Directors does hereby find that the continued increase of COVID-19 cases and hospitalizations in Glenn and Colusa Counties due to the Omicron variant poses an imminent risk to the health and safety those attending meetings of the District's Board of Directors directly impacting the ability to meet safely in person.
- 5. The General Manager and staff are hereby authorized and directed to continue to take all actions necessary to carry out the intent and purpose of this Resolution including,

conducting open and public meetings in accordance with Government Code section 54953, subdivision (e), and other applicable provisions of the Brown Act.

6. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of (i) April 2, 2022, or (ii) such time as the Board of Directors adopts a subsequent resolution in accordance with Government Code section 54953, subdivision (e)(3), to extend the time during which the Glenn-Colusa Irrigation District Board of Directors may continue to meet remotely without compliance with the requirements of Government Code section 54953, subdivision (b)(3).
