BUSINESS ITEMS

Review and Consider Approval of Memorandum of Understanding between Glenn-Colusa Irrigation District and the Glenn-Colusa Irrigation District Office Unit effective October 1, 2022 through September 30, 2023

The District's Labor Committee and the Office Until have met and conferred in good faith regarding wages, hours and other terms and conditions of employment. The District's Labor Committee and the Office Unit have resolved to submit this Memorandum of Understanding (MOU) to the District's Board of Directors to adopt its terms and conditions. The term of the MOU covers October 1, 2022 through September 30, 2023.

The Office Unit salary compensation will be increased by the Consumer Price Index (CPI-U) for the term period of the MOU. Additionally, in the event the District reaches an agreement with the GCID Unit which includes any terms "more favorable" than those set forth, those same "more favorable" terms shall also apply to the Office Unit.

Director Amaro moved to approve the Memorandum of Understanding between the Glenn-Colusa Irrigation District and the Glenn-Colusa Irrigation District Office Unit. Director Knight seconded the motion and it was unanimously approved by the following vote:

ADMINISTRATION

Maintenance

Maintenance Superintendent Richardson provided an update on the Gravel Bar Removal Project reporting that approximately \$173,250 cubic yards of material have been removed as of October 6. He and the Board complimented the staff that have worked on and contributed to the success of the project thus far.

Water Operations

Assistant General Manager Krzys reported that Shasta storage levels are approximately 1.516 million acre-feet. Keswick releases are approximately 4,100 cubic feet per second (cfs), the GCID Pump Station flow is approximately 350-450 cfs and the Williams intertie is approximately 14-25 cfs. The Water department is continuing landowner outreach regarding status of water used. He also reported that there is ongoing coordination for Central Valley Operations (CVO) releases and noted that there is no schedule for when to drop releases at this time.

Board of Equalization Hearing Regarding Setting of 2022-2023 Assessment Rate
At 9:15 a.m., President Bransford stated that it was time for the Board to meet as the Board of Equalization. He, therefore, declared the regular meeting recessed and reconvened the Board, sitting as a Board of Equalization, to hear and determine objections to the valuation, acreage, or any matters pertaining to the assessment coming before it, to be in session.

President Bransford asked whether there were any comments or protests from the public.

There being no verbal or written objections, the President declared the Board of Equalization hearing closed.

The Board reconvened to regular session at 9:16 a.m.

Engineering

District Engineer Dickens reported that the Engineering department has completed the Abel Check design and has opened the bidding process on September 16 and is scheduled to close on October 12. He reported that the gate components for the project have been purchased. He reported that in-channel work on the project is scheduled for completion on February 13th. The project has been budgeted for \$1.6 million.

Water Resources

Water Resources Manager Dawley provided an update on the Gravel Bar Project reporting that the land bridge removal is scheduled for October 13. She also reported that the 90% design has been completed for the Electric Building and will be moved to the final stage of the 100% design. She reported that the current estimate is \$4.8 million with a 3 to 6 month lead time for the electrical components. It was decided by the Board that the Diversion Point Ad Hoc Committee meet to review the status of the Electrical Building process as well as evaluate the Gradient Facility project. She also provided an update on the Restoration Project efforts by RD 108 and GCID.

President Bransford reported that he attended a Sacramento River Settlement Contractor Policy Group meeting with the U.S. Bureau of Reclamation where they discussed Biological Opinions and the 2023 projections.

Manager's Report

Assistant General Manager Greg Krzys reported that groundwater data efforts continue with the County and Davids Engineering. He also reported that there is a continued effort to come to an agreement with Colusa County regarding the Memorandum of Understanding for failed culvert crossings. He also reported that he is working to resolve the easement issues with landowners along the GCID Intake Channel.

GLENN-COLUSA IRRIGATION DISTRICT

RESOLUTION NO. 2022-15 RESOLUTION SETTING ASSESSMENT RATE 2022-2023

WHEREAS, the Board of Directors of the Glenn-Colusa Irrigation District has had before it and has considered a budget and a revenue schedule setting forth estimated income and expenditures; and

WHEREAS, the assessment book of the Glenn-Colusa Irrigation District for the year has been duly completed by the Assessor of said District and delivered to the Secretary of the Board of Directors of said District, within the time and in the manner provided by the "Water Code"; and

WHEREAS, due notice has been given of the meeting of the Board of Equalization, as required by the "Water Code"; and

WHEREAS, said assessments have been duly equalized by this Board of Directors acting as and constituting a Board of Equalization, and the Secretary of this Board of Directors, within ten (10) days after the close of said sessions of said Board of Directors acting as and constituting a Board of Equalization, had the total values as finally equalized into columns and added, and this meeting is held within fifteen (15) days after the close of the said sessions of said Board of Equalization all as required by said "Water Code"; and

WHEREAS, the aggregate assessed value of all the property in the Glenn-Colusa Irrigation District, liable to assessment as it appears on the assessment book or roll of said District, and as duly equalized, for the year 2022-2023 is \$6,133,179.20 and after the deduction of 15 percent for the anticipated delinquencies as provided by the "Water Code" is \$5,213,202.32 on which said last amount, the rate of assessment levied under the provisions of the "Water Code," for the said benefit and purpose of the Glenn-Colusa Irrigation District, should be ascertained; and

WHEREAS, at an election duly called and held on March 31, 1964, the voters of the Glenn-Colusa Irrigation District authorized the execution of a contract with the United States whereby the District agreed to pay the United States up to a maximum of \$210,000.00 each year for water to be delivered by the United States to the District each year; and

WHEREAS, the estimated amount that the District will be obligated to pay the United States in the year 2022-2023 is approximately \$5,339,427.00 and the Board of Directors of the Glenn-Colusa Irrigation District hereby determines, declares and finds that said amount is needed and necessary to be raised by the levy of an assessment upon all the lands within the Glenn-Colusa Irrigation District, and is sufficient therefore, for said purpose.

NOW, THEREFORE, IT IS HEREBY DETERMINED, DECLARED AND FOUND by the Board of Directors of said Glenn-Colusa Irrigation District that each and all the matters herein recited are true and that each and all of the acts and things precedent to, or required by the "Water Code" to be done or performed prior to the levy of this assessment, have been done and performed in every respect in accordance with the "Water Code"; and

BE IT FURTHER RESOLVED AND ORDERED THAT the total amount to be raised by assessment for the purpose aforesaid is the sum of \$210,000.00 and based upon the value of \$5,213,202.32 obtained by deducting 15 percent from the full assessment value, the total rate of assessment for the year 2022-2023 for such purpose be and the same is hereby fixed at \$.040282 cents on each dollar of the assessed value of all lands within the Glenn-Colusa

Irrigation District subject to assessment under the provisions of an as provided by the "Water Code" according to said assessment roll or book of the Glenn-Colusa Irrigation District, for the year 2022-2023 as equalized and the minimum assessment for each parcel assessed separately is hereby ordered to be \$10.00, and;

BE IT FURTHER RESOLVED AND ORDERED THAT said assessment shall be payable in two installments, the delinquency dates of which shall be as specified in Section 26076 of the "Water Code"; and

BE IT RESOLVED, DECLARED, AND ORDERED THAT all tolls and charges for the use of water, and other services, heretofore fixed by the Board of Directors of the Glenn-Colusa Irrigation District remaining unpaid after 5 p.m. on October 17, 2022, shall be and they are hereby added to and do hereby become a part of the first installment of the annual assessment of said District for the year of 2022-2023, levied upon the lands upon which water for which such tolls and charges for the other District services, and shall, and do hereby constitute a lien on said lands.
