#### **BUSINESS ITEMS**

<u>Discuss and Consider Job Description for General Manager, District Management Organization, Process for Selecting Search Firm for General Manager, and Related Matters</u>
Interim General Manager Greg Krzys excused himself from the discussion because he may apply for the General Manager position.

The Board began the discussion focusing on the direction of the District. Director Vann suggested waiting to make any organizational changes until after the new General Manager is hired. He feels it is important to let that individual have input on that topic. The other Board Members agreed.

The Board then reviewed both an older version and the most recent General Manager job descriptions for Glenn-Colusa Irrigation District, as well as the Reclamation District 108 General Manager job description. President Amaro and Director Dennis reported that they would like there to be more focus on internal issues. The Board discussed several possibilities for solutions to allow time for the new General Manager to have the capacity to focus more on internal affairs such as potentially hiring someone to handle external affairs or having the Assistant General Manager assist the new General Manager with internal issues so that there are two resources within the office available to assist with assuring the internal workings of the District are running smoothly.
