BUSINESS ITEMS

Review and Consider Approval of Resolution No. 2024-01 Approving an Amendment to the Glenn-Colusa Irrigation District Investment Policy Allowing for Investment in the California Asset Management Program

Finance Director Jarvis explained that the District's Investment Policy (Policy) is reviewed and readopted on an annual basis and was most recently readopted, with minor changes, on September 21, 2023. The Policy itemizes the specific types of securities that the District is permitted to invest in and states "if a type of security is not specifically authorized by this Policy, it is not an authorized and permitted investment."

For many years, the District has invested in the Local Agency Investment Fund (LAIF) managed by the State Controller's Office. LAIF is an investment pool that government entities are allowed to participate in. LAIF is very useful in managing the District's funds in that it offers a very high degree of investment safety, provides for same-day liquidity, and typically generates a reasonable return on the funds invested.

The California Asset Management Program (CAMP) is a joint powers authority local government investment pool authorized by Government Code Section 6509.7. CAMP was established in 1989, is governed by a seven-member Board of Trustees, is managed by PFM Asset Management, and has over \$14 billion in assets in the investment pool as of September 30, 2023. Finance Director Jarvis shared the similarities and differences between LAIF and CAMP including the yield spread. He explained that the District currently has approximately \$11 million in the LAIF pool, and the yield spread between CAMP (5.56% annualized yield) and LAIF (3.78% annualized yield) is currently 1.78 percentage points (178 basis points). Based on the \$11 million invested in the pool, the additional yield currently offered by CAMP would generate approximately \$16,300 in additional interest revenue on a monthly basis compared to LAIF.

Staff recommends that the Board adopt Resolution No. 2024-01 approving an amendment to the Policy to allow for investment in CAMP. Adding CAMP as a permitted investment will add a cash management tool that the District can utilize when it is beneficial to do so. Staff will be able to transfer funds from LAIF to the District's bank account and then to CAMP (and viceversa) in two or three days to benefit from whichever pool is generating the greater yield. Staff intends to transfer funds from one pool to the other only when the yield spread is significant enough to warrant transferring the funds. Investing funds in CAMP poses no greater risk than investing funds in LAIF.

Director Knight moved to approve Resolution No. 2024-01 approving an amendment to the Glenn-Colusa Irrigation District Investment Policy allowing for investment the California Asset Management Program. Director Bransford seconded the motion and it was unanimously approved by the following vote:

Review and Consider Authorization to Execute Documents Necessary for Participation in the State of California's Purchase Card Program (Cal-Card)

Finance Director Jarvis explained that the District has business credit cards issued by First National Bank of Omaha. There are currently ten cards issued with a combined credit limit of \$30,000. Per the District's Credit Card Use & Expense Reimbursement Policy, credit cards are intended only to be used for travel expenses or when a vendor will not accept a purchase order.

Cal-Card is the State of California's purchasing card program and is administered by U.S. Bank. Both credit cards and purchasing cards work in the same way to issue a payment to a vendor. Purchasing cards differ from credit cards in that they do not provide a revolving line of credit, the balance of the charges must be paid in full each billing cycle, they provide additional methods to restrict purchases such as the ability to block purchases from specific types of vendors and allowing for daily, weekly, and monthly charge limits on specific cards.

More than 2,000 government agencies in California participate in the Cal-Card program. Participation in the Cal-Card program involves no fees or interest charges and offers additional benefits compared to the District's existing business cards. Those benefits include: invoices that are due 45 days from the invoice date which is beneficial when Board meetings are canceled; a 1.35% cash rebate on all purchases, with a potential to increase to 1.80% based on early payment; permanently restricted merchant categories such as money order or cash advance providers; the ability to provide employees digital cards in minutes if necessary; and one combined monthly statement for the program rather than separate statements for each card like the current program.

Due to the additional benefits provided by the Cal-Card program, staff recommends that the Board authorize execution of the necessary documents to participate in the program. Once the Cal-Card program is effective the District's credit cards issued by First National Bank of Omaha will be canceled.

Director Vann moved to approve the authorization to execute documents necessary for participation in the State of California's purchase card program (Cal-Card). Director Knight seconded the motion and it was unanimously approved by the following vote:

ADMINISTRATION

Department Reports

Maintenance

Maintenance Superintendent Richardson reported that the Maintenance Department has continued installing meter turnouts, removed panels from several weirs in preparation for possible storm water, installed 32-2a flume pipe and form floor/wall, repaired erosion on the 'A' drain, continued installation of tailboxes on existing turnouts to support water measurement, completed graveling the 48-1 bank for access during wet weather, completed culvert replacement in coordination with Colusa County at 43-1-05R/Riordan Road. He also reported that he met with Glenn County to tour four failed culvert sites, coordinated with GCID staff on plans for the 32-2a drain flume, participated in the 48-1 modernization preconstruction meeting, and scheduled the removal of the old Tuttle Check structure with Franklin Construction to begin on January 20th.

Water

Water Operations Superintendent Henderson reported that the Main Canal is currently at 750 cubic feet per second. The winter maintenance shutdown period begins on Sunday, January 7, 2024. The Water Department has been communicating and coordinating with water users to ensure all final water orders have been scheduled to occur prior to the shutdown date. Mr. Henderson provided a report back to the Board regarding a Public Participation comment from the December 7, 2023, Board meeting. Mr. Elias Ortiz, a GCID water user expressed concerns about water usage figures and a potential need for reimbursement from the District for his pasture in 2022. After meeting with Mr. Ortiz and gathering data from GCID Water Operators in that area, it was determined that the District did not owe Mr. Ortiz any reimbursement.

(Director Dennis arrived at 9:29 a.m.)

Engineering

Assistant Engineer Privitera reported that the Engineering Department has been coordinating activities related to the Lateral 48-1 modernization project including discussion of site plans for all structures, completing design sets for each of the new structures, and inspecting the sites when the water levels are down. He also reported that the Engineering Department has assisted with Ranch Weir, Lateral 32-2a Flume and Check improvements, and the County Road U culvert failure replacement.

INFORMATION REPORTS

Board Member Report

Director Vann reported that he participated in the Northern California Water Association (NCWA) Executive Board meeting where discussion took place regarding the many changes at the State Capitol.

Review and Consider Approval of Resolution No. 2024-02 Approving the Filing of Applications for Elective Coverage of State Disability Insurance Pursuant to California Unemployment Insurance Code Section 710.5 for Unrepresented Employees, Employees in the Office Unit, and Employees in the Glenn-Colusa Irrigation District Unit and Authorizing the Board President to Sign the Applications on Behalf of the Board

Discussion:

For many years, the District has provided both short-term disability insurance and long-term disability insurance coverage for employees. Coverage for both short-term disability and long-term disability has been provided through insurance contracts purchased through a broker. During the labor negotiations that recently concluded, the District agreed to provide coverage for all employee groups through the State Disability Insurance (SDI) program as soon as administratively feasible. SDI is a replacement for the existing short-term disability insurance coverage. The District will continue to provide long-term disability coverage for employees via privately purchased insurance.

SDI and the existing short-term disability insurance are similar in that they both offer partial wage replacement for employees who are not able to work for specified reasons. Additionally, both SDI and the existing short-term disability insurance provide a similar level of wage replacement—the SDI benefit is between 60% to 70% of the employee's normal wages and the existing short-term disability insurance is 67%. However, compared to the existing short-term disability insurance, SDI does offer the expanded or additional benefits listed below:

- The waiting period for the commencement of benefits for SDI is 7 calendar days whereas with the existing short-term disability insurance it is 60 calendar days. Reducing the waiting period results in employees having greater leave balances available to supplement the disability benefit payment and allows them to maintain full wage replacement for a longer period.
- SDI coverage lasts for 52 weeks whereas coverage under the existing short-term disability insurance lasts for 26 weeks. Both SDI and the existing short-term disability insurance coordinate with the District's long-term disability insurance.
- SDI offers a Paid Family Leave (PFL) benefit, whereas the existing short-term disability
 insurance does not. PFL offers the same rate of partial wage replacement for a period up
 to eight weeks (may be non-consecutive) and may be used to by the employee to care for
 an ill family member or bond with a new child.

Because of these expanded and additional benefits, each employee group communicated their preference for the SDI program over the existing short-term disability insurance coverage during the recent labor negotiations.

Currently, the District pays for both the short-term and long-term disability insurance with no contribution on the part of employees. Statute requires that SDI coverage be funded via payroll deductions. Therefore, forgoing the existing short-term disability insurance and electing SDI coverage will result in a cost to employees and savings to the District. The current SDI withholding

rate is 1.1% of employee wages. The withholding rate is adjusted effective January 1 of each year and is generally between 0.8% and 1.2% of employee wages.

The SDI applications for elective coverage require both a resolution from the governing body approving the filing of the applications and a signature from at least one member of the governing body.

Fiscal Impact:

As a result of forgoing short-term disability insurance coverage purchased through a broker and changes to the long-term disability coverage that result from SDI offering a longer period of coverage than the existing short-term disability insurance, the District is expected to realize a savings of approximately \$27,000 annually.

RESOLUTION OF THE GLENN-COLUSA IRRIGATION DISTRICT BOARD OF DIRECTORS APPROVING THE FILING OF APPLICATIONS FOR ELECTIVE COVERAGE OF STATE DISABILITY INSURANCE PURSUANT TO CALIFORNIA UNEMPLOYMENT INSURANCE CODE SECTION 710.5 FOR UNREPRESENTED EMPLOYEES, EMPLOYEES IN THE OFFICE UNIT, AND EMPLOYEES IN THE GLENN-COLUSA IRRIGATION DISTRICT UNIT AND AUTHORIZING THE BOARD PRESIDENT TO SIGN THE APPLICATIONS ON BEHALF OF THE BOARD

The Board of Directors of Glenn-Colusa Irrigation District (GCID) hereby finds and declares as follows:

WHEREAS, the California State Disability Insurance Program (SDI) provides Disability Insurance and Paid Family Leave (PFL) wage replacement benefits to eligible workers who need time away from their jobs due to specified circumstances; and

WHEREAS, employees who participate in SDI are eligible to receive partial wage replacement for up to 52 weeks per year for a qualifying disability and up to 8 weeks per year of PFL wage replacement benefits to care for a seriously ill child, parent, parent-in-law, grandparent, grandchild, sibling, spouse, or registered domestic partner or to bond with a new child entering the family by birth, adoption, or foster care placement; and

WHEREAS, the short-term disability insurance currently provided to all GCID employees has a similar level of disability benefits as SDI but a considerably longer waiting period prior to the benefits starting; and

WHEREAS, GCID employees do not currently enjoy a benefit like that provided by PFL; and

WHEREAS, the unrepresented employees of GCID have communicated a preference to participate in the SDI program at their own expense; and

WHEREAS, pursuant to Unemployment Insurance Code section 710.5, a public agency may elect SDI coverage for unrepresented employees by applying for such coverage with the State Employment Development Department; and

WHEREAS, the Glenn-Colusa Irrigation District Office Unit (Office Unit) is a recognized employee organization and has negotiated a Memorandum of Understanding in good faith with GCID whereby GCID has agreed to provide coverage through the SDI program as soon as administratively feasible with the understanding that such coverage will result in a cost to Office Unit employees; and

WHEREAS, the United Public Employees of California Local 792—Glenn-Colusa Irrigation District Unit (GCID Unit) is a recognized employee organization and has negotiated a Memorandum of Understanding in good faith with GCID whereby GCID has agreed to provide coverage through the SDI program as soon as administratively feasible with the understanding that such coverage will result in a cost to GCID Unit employees; and

WHEREAS, pursuant to Unemployment Insurance Code section 710.5, a public agency may elect SDI coverage for employees represented by recognized employee organizations such as the Office Unit and the GCID Unit provided the election is the result of a negotiated agreement between the public agency and the recognized employee organization.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of GCID as follows:

- The Board of Directors approves the filing of applications for elective coverage of State Disability Insurance pursuant to California Unemployment Insurance Code section 710.5 for unrepresented employees and employees in the Office Unit and the GCID Unit and authorizes the Board President to sign the applications on behalf of the Board.
- 2. The Finance Director is authorized to execute and submit any and all additional information necessary to the State of California in order to effectuate the intent of this Resolution.
