

BOARD OF DIRECTORS AS UNOPPOSED CANDIDATES**

WHEREAS, Glenn-Colusa Irrigation District (GCID) pursuant to California Water Code, section 211074 provides for the election of Board members to terms of four years; and

WHEREAS, two (2) positions of the GCID board are now open for election on or about August 29, 2023; and
