Authorize Payment of Claims

General Manager Sutton highlighted an item related to the Bureau of Reclamation's (BOR) rescheduling charges for increased October diversions at the request of Director Bransford. In coordination with BOR, the District diverted additional water during October for rice decomposition and waterfowl in an effort to allow for reduced releases out of Keswick Reservoir in November to avoid the stranding of Winter Run Chinook salmon egg nests on the upper river. As such, after bringing to light the coordination and collaboration regarding these actions to the BOR, and the fact that the District could have avoided the subject rescheduling fees by pushing those increased diversions into November, the BOR agreed to reverse the rescheduling fees, saving the District over \$50,000.

Director Bransford moved to approve the payment of claims #24 16830 through #24 16917, in the amount of Six Hundred Fifty-Four Thousand, Nine Hundred Forty-Five Dollars and Forty-One Cents (\$654,945.41), and approve the November 21, 2024, Regular Board meeting minutes and the November 25, 2024, Special Board meeting minutes. Director Knight seconded the motion, and it was unanimously approved by the following vote:

Department Reports

Water

Water Operations Superintendent Henderson reported that the Main Pump Station pumps have been shut off for the several days recently due to elevated river levels. He hopes to turn the pumps back on today. He also reported that the forecast underestimated the amount of rain brought in by the recent storms, resulting in weirs and I-beams catching trash and backing water up further than expected. Currently, all weirs and I-beams are being removed, and will remain out for the incoming weather system.

Maintenance

Maintenance Superintendent Richardson reported that the Maintenance Department has been repairing erosion on the main canal; cleaning laterals and drains; continuing to install tail boxes; repairing and cleaning Symons forms; sand blasting and painting fabrication projects; and building a wall in the records room for the Remote Tracker equipment. He also reported on the chemical purchase/bid process, work on the USDA grant project descriptions and budget, and the Gradient Facility Project permitting site visit, and progress on the Middle Creek restoration project.

Engineering

Interim District Engineer Privitera reported on the following items: Lurline Check and Siphon Replacement Project; District inventory update; Winter shutdown planning; RemoteTracker data collection implementation; Private lateral easement acquisition; GIS data creation and next steps; and the Middle Creek Restoration Project.
