BUSINESS ITEMS

Water Quality Presentation by Engineering Technician Matt Collins

Interim District Engineer Privitera introduced the summer Engineering Intern Brady Holzapfel, Water Department Intern Cameron Carpenetti, Engineering Technician Kevin Berry, and Engineering Technician Matt Collins, who has recently graduated from Chico State University with his Master's Degree.

Engineering Technician Collins gave his Water Quality Presentation that he used as his master's thesis after working as an Engineering Intern for the District last summer. The goal is to create a GIS tool to store water quality data that can be utilized throughout the District.

<u>Discuss and Consider Further Water Rate Reduction Due To Low Commodity Prices</u>
At the June 5, 2025, Board of Directors meeting, during public comment, a District water user mentioned that Reclamation District 108 took action to reduce their water rates for the 2025 irrigation season due to low commodity prices. He requested that the Board consider similar action.

The Board discussed the continued concern over low commodity prices, which have contributed to a challenging environment for generating farm profits. The Board considered the fiscal impacts of various actions to reduce water rates in an effort to ease the burden on District water users during these difficult times. In February, during the District rate setting conversation, the Board ultimately elected to set the 2025 water rates in an amount that resulted in a reduction of approximately \$7.11 per acre from the initially proposed 2025 rate. However, it was acknowledged that such reductions are not likely to be financially sustainable into the future. It was also noted that the District had reduced the fees for rice decomposition water from \$10 per acre-foot to \$5 per acre-foot the past two years.

After discussing, the Board chose not to further reduce the water rates for 2025, noting that when considering all factors, the current-year District water rates are comparable to those of Reclamation District 108. The Board will revisit these considerations during discussions on the 2026 water rates.

<u>Discuss and Consider Adoption of Resolution No. 2025-06 Authorizing Conditional Approval for Payment of Claims in the Event of a Cancelled or Rescheduled Board Meeting</u>

Finance Director Jarvis reported the Board typically meets on the first and third Thursday of each month. Each regular meeting agenda includes the item to authorize payment of claims. Occasionally, circumstances may warrant canceling or rescheduling a regular meeting.

However, doing so can delay claim payments and potentially result in late fees on outstanding bills. To avoid any possible late fees, the Board has opted to hold meetings with a limited agenda primarily to approve the payment of claims.

Resolution No. 2025-06 authorizes the Board President or Vice President to conditionally approve the payment of claims in the event a regular meeting is cancelled or rescheduled, provided that all conditionally approved claims are presented to the Board for formal approval at the next regular meeting.

Staff was directed to develop guidelines and protocols, including procedures for addressing budgeted capital items and significant unforeseen expenditures, to be considered at a future meeting to augment the new payment of claims policy.

Director Bransford moved to approve Resolution No. 2025-06, Authorizing Conditional Approval for Payment of Claims in the Event of a Cancelled or Rescheduled Board, and directed staff to work to develop further guidelines related to this policy for Board consideration. Director Knight seconded the motion, and it was unanimously approved by the following vote:

He also reported that the Abatement Department completed a Cascade treatment in the Main Canal for aquatic weed control on June 18, 2025.

WHEREAS, the Board of Directors of Glenn-Colusa Irrigation District regularly scheduled meetings are held on the first and third Thursdays of each month; and

WHEREAS, the Board of Directors approves the payment of claims at each of these regular meetings; and

WHEREAS, from time-to-time circumstances are such that the Board of Directors elects to cancel or reschedule a regular meeting; and

WHEREAS, such cancelation or rescheduling of a regular meeting results in the payment of claims being delayed and may result in the District being assessed late payment fees on outstanding claims; and

WHEREAS, the District values paying its vendors promptly and desires to avoid being assessed late payment fees; and

NOW, THEREFORE, BE IT RESOLVED AND DETERMINED by the Glenn-Colusa Irrigation District Board of Directors as follows:

- In the event a regular meeting of the Board of Directors is cancelled or rescheduled either
 the President or the Vice President of the Board of Directors is authorized to conditionally
 approve the list of payments that would have been presented for approval at such
 cancelled or rescheduled meeting.
- Upon such conditional approval, either the President or the Vice President of the Board of Directors, the Secretary, and the Treasurer are authorized to sign warrants for the payment of the conditionally approved claims.
- Once signatures are obtained, the Treasurer is authorized to make the conditionally approved payments.
- At the next regular meeting of the Board of Directors all conditionally approved claims paid pursuant to the authorization provided by this resolution shall be presented to the Board of Directors for approval.
